

REMINDERS TO EXHIBITORS - IMPORTANT TRIAL INFORMATION

- Thurber Hall will be open for set up from 1:00 PM 6:00 PM on Thursday, Dec. 11, 2025. Exhibitors may bring in crates, chairs, and other equipment during that time and set up in designated areas. The official AKC O/C Match begins at 2:00 p.m. on Thursday. If someone is signed up for the match and traveling in, know that your time will be honored should you arrive after your turn. Friday and Saturday matches will begin 15 minutes after all Judging Books are submitted to the Show Secretary.
- Officers and Club Members of Old Pueblo Dog Training will be eligible to compete at these trials. Likewise, the Show Secretary, the Show Chair, and any other volunteers helping with the running and organization of these trials will be eligible to compete.
- CRATES & NDZ! All Participants are expected to have a crate/contained place where
 their dog can relax. In support of the AKC rule to "exit the ring with the dog under
 control" there will be definite NO DOG ZONES (NDZ) at this trial. This will include
 checking in, arm-band pick-up, checking the rally score board, etc. We will all work
 together to support each and every run at our trial without adding additional "proofing"
 as handlers compete, enter, or exit the ring.
- All dogs must always be on leash when on trial grounds except when in the designated warm up area or while competing in the ring. The entire Pima County Fairgrounds property is considered the trial grounds. For safety reasons flexi-leads may not be used in or around the building.
- Obedience and Rally Class Transfers will be accepted as space permits, in accordance with Chapter 1, Section 16a & b of the AKC Obedience Regulations, and Chapter 1, Section 15 & 16 of the AKC Rally Regulations. Requests for class transfers must be made in writing and presented to the Trial Secretary at least 30 minutes before the start of each day's trial (and preferably the day before!). Forms will be available in a book at the Secretary's Table during the Trials. Prior to Friday, December 12, 2025 pre-trial transfer requests may be made by emailing the Trial Secretary.
- Obedience and Rally jump heights will be organized by jump height to the extent possible. Running Order in classes involving jumping exercises will be small to tall each day.

- All Rally classes will have a walk-through for handlers without their dogs prior to the start of judging for that level.
- In the Novice A, Preferred Novice, and Beginner Novice Obedience classes, a walk-through prior to the start of the class will be held for handlers without their dogs. The judge will be available in the ring during this period to brief the handlers and answer any questions they might have.
- No dogs may be left in the building overnight. Exhibitors are responsible for cleaning up after their dogs and leaving their crating areas clean.
- The AKC is committed to creating a safe and respectful sport environment for all. If you
 need to talk to someone or need help, please call 800. 656.HOPE (National Sexual
 Assault Hotline) or text HOME to 741-741 for free, 24/7, confidential services from
 trained crisis counselors.
- In the event of a tie score, any dog not present for the runoff forfeits its rights to the ribbon and/or trophy.
- IMPORTANT GROUNDS/PARKING INFORMATION: While December can be cooler in Tucson, no dog should be left in a car without adequate ventilation (Windows down, Hatch door raised, etc.) as the sun still can heat up a vehicle even on a cooler day in the desert. We will take action to rescue and report any dog deemed to be in a potentially harmful situation to any Show Committee Member.



AKC[®] Code of Sportsmanship and Civility

Preface: The tradition of competitive purebred dog events predates 1884—the year the American Kennel Club (AKC®) was founded. Those involved in these sports share core values, including a strong commitment to sportsmanship and a welcoming, respectful culture that embraces the diverse community united by a love of dogs.

These values are evident across all aspects of the sport: conformation, performance, companion, and family dog activities. Many believe that the enduring principles of sportsmanship and civility are key reasons the sport has thrived for over 140 years.

Recognizing that periodically reaffirming our shared values strengthens our community, the revised code will be shared widely to highlight the foundational values and principles that define the sport.

- Sportspeople always place the welfare of their dog above all else.
- Sportspeople prioritize the long-term health and preservation of their breed, making decisions that reflect a deep commitment to responsible breeding and ownership.
- Sportspeople respect the history, traditions and integrity of the sport of purebred dogs.
- Sportspeople conduct themselves in a manner that reflects positively on the sport, the American Kennel Club, and themselves.
- Sportspeople appreciate, encourage and support all who associate with and participate in the sports by fostering an environment where respect, equity, inclusion, and courtesy are foundational.
- Sportspeople understand, uphold and abide by all AKC bylaws, rules, regulations and policies.
- Sportspeople contribute to a positive atmosphere at events by avoiding negative gossip, disparagement, or unsportsmanlike behavior.
- Sportspeople extend their values of civility, fairness, and respect to all digital and social media platforms.
- Sportspeople actively support the education and mentorship of newcomers, helping them learn the rules, values, and traditions of the sport in a respectful way.
- Sportspeople recognize that they are role models in the sport, and strive to lead by example through humility, kindness, and ethical conduct.
- Sportspeople treat fellow exhibitors, judges, officials, volunteers, spectators, and AKC staff with dignity and respect, regardless of experience, background, or differences in opinion.

- Sportspeople are committed to fair play, honesty, courtesy, and competition, approaching both winning and losing with grace.
- Sportspeople understand that strong competition and civility can—and should—coexist. They appreciate the quality of their competitors, and the effort put forth by others.
- Sportspeople uphold their responsibilities to the sport of purebred dogs and refuse to let personal gain or self-interest influence their decisions or behavior.
- The sportsperson judges only on the merits of the dogs and considers no other factors.
- The sportsperson judge or exhibitor accepts constructive criticism.
- The sportsperson exhibitor declines to enter or exhibit under a judge where it might reasonably appear that the judge's placements could be based on something other than the merits of the dogs.
- The sportsperson exhibitor refuses to compromise the impartiality of a judge.
- Sportspeople are willing to share honest and open appraisals
 of both the strengths and weaknesses of their breeding stock.
- Sportspeople decline to exploit any positions of authority or recognition for personal advantage.
- Sportspeople appreciate those that have gone before them and realize they are responsible for maintaining and enhancing the sport for future generations.



Rally Trial Transfer Form



RALLY TRIAL: TRANSFER FORM

Present this form to the Trial Secretary or the Superintendent at least 30 minutes prior to the start of each trial.

Refer to the Rally Regulations - Chapter 1, Section 13, Transfers.

- The club will clearly state in its premium list whether transfers will or will not be allowed. If no statement is provided in the premium list the default is to allow transfers.
- After a dog earns a rally title, it may be transferred to another class in a future trial, even though the closing date for the trial has passed, provided the club offers transfers.
- A transfer from a rally class to a rally class may be requested if, according to the owner's records the
 handler and dog are eligible and the dog has completed the requirements for the title after the
 closing date of the trial in which the advanced entry is to be made.
- Transfers from an "A" to "B" class at the same level are allowed provided the host club allows transfers. (When a club does not allow transfers, refer to Section 14. Entry of Ineligible Dog.)
- The request for a transfer must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial.
- Transfers may be approved provided the class and judge are available, and the class has not reached its limit.

- The club will clearly state in its premium list whether transfers will or will not be allowed. If no statement is provided in the premium list the default is to allow transfers.
- After a dog earns an obedience title, it may be transferred to another class in a future trial, even though the closing date for the trial has passed, provided the club offers transfers.
- A transfer from an obedience class to an obedience class may be requested if, according to the
 owner's records the handler and dog are eligible and the dog has completed the requirements for the
 title after the closing date of the trial in which the advanced entry is to be made.
- Transfers from an "A" to "B" class at the same level are allowed provided the host club allows transfers. (When a club does not allow transfers, refer to Section 16b. Entry of Ineligible Dog.)
- The request for a transfer must be in writing and presented to the superintendent or trial secretary at least 30 minutes prior to the start of each trial.
- Transfers may be approved provided the class and judge are available, and the class has not reached its limit.
